Fraunhofer Bessel Research Awards

The Fraunhofer-Gesellschaft for the Promotion of Applied Research e.V. and the Alexander von Humboldt Foundation grant up to three research awards annually to internationally renowned academics from abroad in recognition of their outstanding academic performance **in applied research** to date.

Academics can be nominated for the award if their accomplishments in applied research to date have earned them recognition as internationally outstanding specialist researchers and if they are expected to continue producing cuttingedge academic achievements and have a lasting impact beyond their area of specialisation.

Academics from abroad, regardless of their discipline or nationality, may be nominated for a Fraunhofer Bessel Research Award, **provided that they have received their doctoral degree within the past 18 years**. The awarding institutions aim to achieve a good balance between genders and a high level of diversity among its fellows in all areas. We therefore expressly welcome the nomination of female researchers and members of underrepresented groups.

In addition, award winners will be invited to conduct a research project of their own choosing with a specialist colleague at one of the Fraunhofer Institutes in Germany. The project duration of about six to twelve months may be divided into segments.

The award amount totals EUR 45,000. In Germany, research awards are generally exempt from income tax under German tax law. In addition, further expenditures (such as travel or language courses) are covered in the context of the invitation to stay in Germany for research purposes. Nomination Entitlement

A director or senior academic of a Fraunhofer Institute must take the initiative to nominate a candidate for the Fraunhofer-Bessel Research Award. If the nomination is not submitted by a member of the management team of the institute, it must approve the nomination. Nominations may also be initiated by award winners of the Humboldt Foundation working abroad, provided that the nomination is made jointly with a colleague working at a Fraunhofer Institute in Germany. Self-nomination is not possible.

Nomination Prerequisites

The nominee's outstanding academic qualification must be internationally recognised and documented by corresponding successes in research, such as positively received academic publications or previous awards. The assessment also considers the individual life journey and educational background, also and especially in terms of equal opportunities and accessibility.

The Fraunhofer Bessel Research Award can only be granted once to any one academic. Researchers who have already received a research award for their academic achievements from the Alexander von Humboldt Foundation are not eligible to be nominated.

Furthermore, the nominee should not have recently won any awards or fellowships in Germany for his or her academic accomplishments. At the time of nomination, the nominated candidate must have been predominantly living and working abroad for at least five years. Moreover, the nominees must not have held or accepted an offer of permanent employment in Germany prior to the selection date. In cases of doubt, please contact the Alexander von Humboldt Foundation in advance.

Nominating academics must guarantee that they can provide the necessary infrastructure for the award winner's own research projects or lecture tours (e.g. access to libraries, materials, facilities). German hosts are also expected to be well prepared for the award winner's research stay and to act as his or her personal mentor (e.g. finding accommodation).

Selection Procedure

An independent <u>Selection Committee</u> appointed by the Alexander von Humboldt Foundation meets twice a year, in spring and autumn, to decide on the nominations in the respective round. Reviewing an application takes approximately six months. Nominations may be submitted online at any time. Visit the Alexander von Humboldt Foundation's website for further information on the <u>online nomination process</u> and all necessary documents as well as access to the online nomination system. A confirmation or receipt will be issued after the application has been submitted.

Nominators are responsible for ensuring that their documents are complete. If the nomination is not submitted by a member of the management team of a Fraunhofer Institute, they must be informed of the planned nomination and must agree with the submission. The release of the nomination by the management team is in such a case done by co-signing the "Information on an Invitation to Germany". Incomplete nominations might be excluded from the selection procedure.

General Regulations

The research award recognises the entire academic record as well as the personality of outstanding academics. Therefore, it is assumed that award winners have complied with the <u>rules of good scientific practice</u> and the relevant laws valid at the respective research location in their previous academic work and will comply with them during a possible research stay in Germany.
