

Appendix 1 to the Fellowship Guidelines of the Federal Foreign Office of 8 November 1996 in the amended version of 16 December 2012

All amounts are to be understood as maximum amounts, whereby the amounts stipulated in categories I-III may be subject to a maximum lower deviation of ten per cent.

1. The following *fellowship categories* are formed and monthly *fellowship payments* stipulated in accordance with Article 2, Para. 1 of the Guidelines:

Category I	Students and trainees yet to complete examinations (assessment basis: cost of living requirements in accordance with the Federal Training Assistance Act (BAföG), plus supplement for additional costs related to living abroad)	650.00
Category II	Graduates with a foreign university degree which equates at least to a German university intermediate diploma or Bachelor degree	750.00
Category III	Doctoral candidates and post-doctoral students (assessment basis: graduate funding rates applicable in German federal states and those granted by the German Research Foundation (DFG) plus seniority supplement), plus fellowship holders with university degrees equating to the German university diploma who come to Germany for research purposes and have demonstrably pursued academic activities for at least two years at the time of the fellowship's commencement	1,000.00
Category IV	Young academics commensurate with a German university assistant	2,500.00 (previously: 2,100.00)

	Fellowship category	Amount (in EUR)
Category V	Academics commensurate with a German university lecturer/private lecturer	3,000.00 (previously: 2,300.00)
Category VI	Academics commensurate with a German university professor of salary grade W2/W3	3,600.00 (previously: 3,000.00)

2. The monthly family allowance in accordance with Article 2, Para. 4 of the Guidelines amounts to

for accompanying spouses	276.00
for children accompanying the fellowship holder, the amount of the family allowance shall be determined in line with the child benefit payments in accordance with the Federal Child Benefit Act (Bundeskindergeldgesetz, BKGG)	

A precondition of the payment of the family allowance for accompanying children is the submission of a notice of rejection in the wake of an application for state child benefit, or that the legal status is such that a claim to child benefit applies under no circumstances. In the latter case, the fellowship organisation shall be obliged to document the decision regarding the payment of a family allowance for accompanying children in a comprehensible manner.

3. The *ancillary benefits* for fellowship holders in accordance with Article 3 of the Guidelines shall be determined as follows:
